TC 85/16      County Durham Association of Local Councils : Annual General Meeting Update

The Town Clerk updated Members on two motions discussed and approved by Members present at the AGM of the County Durham Association of Local Councils held on 22<sup>nd</sup> October 2016.

At the meeting, CDALC approved the motion put forward by Bishop Auckland Town Council with the addition of the words 'gender prejudice' added to the motion as follows:-

***'We are proud to live in a diverse and tolerant society. Racism, gender prejudice, xenophobia, homophobia, religious intolerance and hate crimes have no place in our county. Shildon Town Council condemns all such intolerance and hate crimes unequivocally.***

***We will not allow hate to become acceptable and will work with the Police and Crime Commissioners and others to fight prejudice and hate crimes. We reassure all people living in the area that they are valued members of our communities.'***

**Recommended** that the Town Council adopt the motion and issue as a public statement.

TC 86/16      Proposal to Remove Street Lights Road No. 35 Middridge Lane : Update

The Town Clerk updated Members on the proposal to remove street lights at Road C35 Middridge Lane and informed Members of Durham County Council's proposal to remove street lighting as part of the ongoing Street Lighting Energy Reduction Project which was approved by the Council's Cabinet on 12<sup>th</sup> December 2012.

Further to the Town Council's response on the consultation to retain lighting columns at the point where pedestrians cross the carriage way on Road No. 35 Middridge lane, Durham County Council had stated that the decision to remove the street lighting had not changed and removal was intended to proceed as per the recommendations in the risk assessment as and when they can be programmed in.

TC 87/16 Durham County Council : Public Consultation on Implementation of a Public Space Protection Order (PSPO) for Dog Control

The Town Clerk informed Members of a public consultation to be carried out by Durham County Council on the implementation of a countywide Public Space Protection Order (PSPO) for dog control.

Fenced off play areas which are owned and managed by Durham County Council are included in the criteria for the countywide PSPO for dog control. It was reported that if a parish/town council wished to be covered by any revised arrangements under a PSPO then an approach would need to be made to Durham County Council in order for play areas to be considered to be covered. Durham County Council have stressed that existing Wardens and PCO's numbers are finite across County Durham.

**Recommended** that the Town Council resolve to support the implementation of a countywide Public Space Protection Order (PSPO) for dog control and to request Durham County Council to consider including parks operated by the Town Council within the PSPO.

TC 88/16 Initial Proposals for new Parliamentary Constituency Boundaries in the North East

The Town Clerk informed Members of the initial proposals for Parliamentary Constituency Boundaries in England and the proposal to reduce the number of constituencies in the North East from 29 to 25.
