Section 106 Funding : Hackworth Park, Shildon

Members received information from the Town Clerk regarding the intention to submit an application for Section 106 funding to provide play equipment within the under 5's and natural play area, Hackworth Park and asked Members to consider a proposal to demolish the Bowling Pavilion as a subsequence of issues outlined at previous meetings. The Town Clerk also informed Members of the intention to include for a wooden building to house users of the area within the Section 106 bid and of informal discussions held with officials of the Shildon Town Bowling Club.

**Recommended** that a Section 106 Funding Application be submitted to Durham County Council for the provision of an under 5's play area and replacement play equipment within the Natural Play Area together with the demolition of the Bowling Pavilion and replacement wooden building to house users of the area.
