SA 27/17 Civic Hall Performance

The Town Clerk advised Members of the trading position for the month of August 2017 and advised that both bar and food sales significantly exceeded budget. Similarly for the year to date, both bar and food sales exceed budget resulting in an overall financial performance of £19k better than the budget.

SA 31/17 Shildon War Memorial

The Town Clerk updated Members on the progress of an application for funding for conservation work to the Shildon War Memorial submitted to the War Memorials Trust Grants Scheme.

The War Memorials Trust Grants Scheme has confirmed that up to £4,470 had been granted to the Town Council in order to facilitate the conservation work. The balance of the funding required to complete the project was £1, 486 excl VAT and an application was to be submitted to the Bishop Auckland and Shildon Area Action Partnership for funding from the Neighbourhood Budgets of Councillors H Nicholson and S Quinn.

- b. the project be supported and facilitated by the Town Council on behalf of the residents of Shildon
- c. an application be submitted to the Bishop Auckland and Shildon Area Action Partnership for funding in the sum of £1,486 from the Neighbourhood Budgets of Councillors H Nicholson and S Quinn for the balance of funds required to complete the conservation work.
